2. That the School started in the year 2023, in the name and style of **VELAMMAL ACADEMY** situated at "Velammal Avenue", 7th Cross Street, S & P Garden, Nolambur, Chennai - 600 095.





3. That the said school is being run by **VELAMMAL CHENNAI EDUCATIONAL TRUST** a registered Trust, registered under the Trust Act, having its registered office at No. 21 - A, Nambikkai Illam, Arudhara Street, T.S.Krishna Nagar, Mogappair, Chennai – 600 037 and the **“Trust is of a Non-Proprietary Character in nature”**.
4. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
5. That no member of the School Management Committee is related to each other.
6. That no part of income from the Institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and nonrecurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
7. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
8. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
9. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
10. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school. 9 That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.



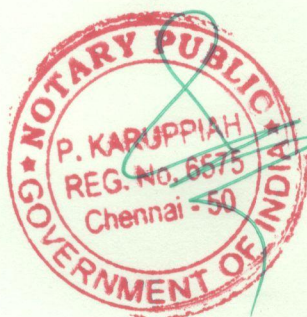



11. That the school will ensure that all required infrastructure is available with the school before starting classes.

That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the post affiliation conditions contained in affiliation byelaws along with general rules.
