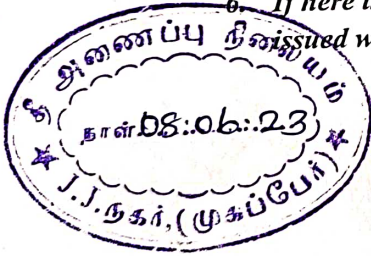

  - b) The staircase treads and flooring shall be treated with rough finish (Grooving) to Avoid falling of children.

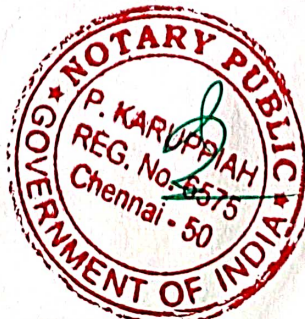


