

Data taken to account for the caluations are as per the Guidelines given in the NBC.

As per IS 1172, from the required water supply assumptions are as follows

Dor drinking purpose : 5 lit.Head / Day

Drinking water for the total Nos. of person : 1500 person X 5 lit = 7500 lit / day

Therefore water other drinking & cooking purpose is :60000-7500 = 52500 lit / day

As per IS 1172, for WC flushing System, the water Consumption perday is assumed as 450 lit per person

Therefore 1500 person water consumed is 1500X20 = 30000 lit / day

water taken for collection tank 52500-30000 = 22500 lit / day

As explained above, 6750 lit of Effluent is connected with septic tank and treated. The treated water is allowed to the dispersion trenches provided in the site. The above water will be soaked in the earth beneath the applicant site. No quantity of water will be connected to the public drainage. Therefore no amount of sewage water will be expelled from the site.

As per the above details, I certify that the treatment plant proposed within the site is more than sufficent for treating for treating os waste water produced. And the septic tank and the dispersion trenches provided will be sufficient for the treatmrnt of sewage water and the soaking of the treated Effluent.




